Applications are invited from unemployed youth/interested persons of UT of Jammu and Kashmir who intend to establish Fish Seed Hatchery (Trout Hatchery) under the scheme "Pradhan Mantri Matsya Sampada Yojana" (PMMSY) during the year 2022-23.

The applications shall be invariably submitted in the respective offices of Dy. Director/Chief Project Officer/Assistant Director Fisheries of the concerned District/Project upto 15th of October 2022.

Terms & Conditions

1. The applicant shall submit Detailed Project Report (DPR) with justification, capital cost, recurring cost involved, source of funds for meeting the beneficiary share including bank consent wherever relevant to meet the beneficiary share and undertaking of beneficiary to the effect that no other government assistance is availed under the proposed project.
2. The water source, to be utilized for the Trout culture should be perennial in nature, preferably spring source, having suitable physio-chemical parameters for Trout Culture with water temperature below 18 degrees centigrade and suitable Dissolved Oxygen Content.
3. Documentary evidences of availability of requisite land free from all encumbrances along with necessary clearance/permission from concerned authority to establish the Hatchery unit.

4. Trout fish Hatchery shall have a minimum capacity of 10 lakh fry/ Year or 15 lakh Eyed ova of trout/cycle in a minimum area of 0.4 Ha or at least 1 acre.
5. The Trout hatchery will include at least 4 raceways like brood stock raceways, nursery raceways, etc. Further, it would include feeding tank/fry tanks, waterfeeding/drainage channel & electric supply, required infrastructure and other facilities.
6. Interested individuals can apply through Assistant Director, Fisheries of their respective Districts or Directorate of Fisheries Jammu/Kashmir.
7. Mere submission of application form does not confer any right to avail assistance under the scheme and is subject to the availability of funds under the said scheme.
