The Trout Fishing season is commencing w.ef <u>04.04.2024</u> and the <u>site</u> for booking and generation of Trout Angling permits through on-line mode shall open on <u>03.04.2024</u>. The following information/instructions are brought to the notice of the all concerned for implementation/enforcement in letter and spirit.

- The Trout Permits for angling in various streams/beats will commence from <u>04.04.2024</u>, the booking and generation of Trout permits will start through On-line mode w.e.f. <u>03.04.2024</u>
- The permits shall be issued through On-line mode for which the link "angling.jkfisheries.co.in" shall be also available on Departmental Website (www.jkfisheries. (n)). The link shall be activated w.e.f. 03-4-2024 for booking/generation of Trout permits.
- The Trout Fishing permits will be available through On-linemode for esteemed Foreign Anglers throughout the week and, however, for local esteemed Anglers it will be available for Saturday, Sunday, Tuesday and Thursday(04 days in a week).
- The Trout beats for fishing will be allotted on first come first serve basis. Few beats shall remain reserved/restricted for conservation purposes.
- The Esteemed Anglers are requested to co-operate with the Department for ensuing judicious trout angling in all the streams and book the permits as per the availability.
- The Esteemed anglers are requested not to rely upon any unauthorized person/persons posing themselves as agents/touts for the issue of permits for the Department. In case of any mischievous things, the Department shall not be responsible.
- The above arrangement shall be subject to review/modification/cancellation as per existing conditions of the trout streams and angling report.

- 8. For implementation of conservation measures especially in the month of April and May, beats existing in lower belts shall be preferred by the esteemed anglers because of highcurrent of water. Subsequently, the beats in higher reaches are suitable for good fishing as soon as water level startsstabilizing.
- 9. The permits issued shall be non-transferrable and fee to be nonrefundable.

Esteemed Anglers are requested to cooperate with the Department for strengthening of long prosperous world class Trout Angling in Kashmir in particular and in the UT of J&K in general.
