The supplier shall replace the same with the material of required specification and in case of his failure same shall be arranged from alternate sources at the cost of supplier. The supplier shall be bound to lift such sub-standard supplies immediately from the stores of the Project.
- Any batch of Drugs, Medicines, supplied shall be subject to random testing through Govt/Private Laboratory at the discretion of survey /Inspection Committee
- The Product should be supplied in company original packing having proper batch No / Date, Date of Manufacture. Shelf life for each item should be more than one year from the date of placement of supply order or receipt of supplies whichever is later.
- The material shall be received in presence of a team of officers to be nominated by the Joint Director Fisheries (South/ North), Kashmir Division.
- 5. The Chief Project officer Kokernag/Senior Project officer Trout Fish Feed Mill Manasbal shall ensure receipt/verification of material in presence of the nominated committee. Payment shall be released to the agency only after receipt and acceptance of supplies from the committee and its proper entry in relevant stock registers.
- The Chief Project officer Kokernag and Senior Project officer Trout
 Fish Feed Mill Manasbal will be wholly and solely responsible for
 quality control of the supplies.
