ANNUAL RATE CONTRACT

Sub; Fixation of Annual Contract for Supply of Whole Wheat through (GeM) for the year 2023-24.

Ref: - i. This office Gem Bid No GEM/2023/B/4172383 dated: 06.11.2023 ii. Constitution of Bid Opening Committee Order No; 540-Fisheries of 2023 dated: 17. 11.2023

M/S Samzan, Sanatnagar, Srinagar offered a bid price of Rs. 36.96 per kg in respect of Whole Wheat in response to the Gem /reverse Bid No: GEM/2023/R/273716 dated: 05.12.2023 which was found lowest by the Committee constituted vide Fisheries Order No; 540-Fisheries of 2023 dated:17.11.2023. However, consequent upon the negotiations, the firm/bidder agreed to slash down the rates from Rs. 36.96 to Rs.34.50 per kg for the item viz Whole Wheat (Schedule 2 in the GeM Bid) vide his letter No SAM/SGR/2023/12-06 dated:14.12.2023 and same has been accepted by the Department.

Now therefore, as recommended /approved by the Committee, the Annual Rate Contract for supply of Whole Wheat (through Gem) for the year 2023-24 is fixed with the M/S Samzan, Sanantnagar, Srinagar strictly on the terms and conditions set apart herein asunder which shall form an integral part to this supply order.

The required quantity of Whole Wheat shall be received from the above supplier by the Chief Project Officer, Trout Fish Farming Project, Kokernag & Senior Project Officer, Trout Fish Feed Mill, Manasbal respectively.

Terms and conditions:

- The material shall be strictly of Standard quality. In case any substandard material is supplied the same shall be rejected at the cost and risk of the supplier. The supplier shall replace the same with the material of required specification and in case of his failure same shall be arranged from alternate sources at the cost of supplier. The supplier shall be bound to lift such sub-standard supplies immediately from the stores of the Project.
- The material shall be received in presence of a team of officers to be nominated by the Joint Director Fisheries (South/ North), Kashmir Division.
- The committee shall obtain samples at their will from each consignment and refer the same to any reputed laboratory for examination with regard accuracy of specification and the supplies shall be accepted subject to the accuracy report of the laboratory
- Challan of the transport company in original should be provided, without which no payment shall be released by the authority.
- 5. The Chief Project Officer, Kokernag & Senior Project Officer, Trout Fish Feed Mill, Manasbal shall ensure receipt/verification of material in presence of the nominated committee. Payment shall be released to the agency only after receipt/verification, final testing and acceptance of supplies (at destination i.e. Kokernag/Mansabal Kashmir) from the committee and its proper entry in relevant stock registers.
- The Chief Project officer Kokernag and Senior Project officer Trout Fish Feed Mill Manasbal will be wholly and solely responsible for quality control of the supplies.
- The supplier shall execute an agreement with the Department dully signed by him under seal and signature and attested by the Judicial Magistrate 1st Class /Competent Court of Law.
- The rate mentioned above are FOR stores of Chief Project officer Kokernag/ Senior Project officer Trout Fish Feed Mill Manasbal and shall include all taxes/duties/CGST/SGST, transportation and other incidental carriages.
- This rate contract shall be valid for (01) One Year from the date of issuance of this Rate Contract.
- This rate contract shall be subject to the other terms and conditions mentioned in the bid document of GEM/2023/B/4172383 dated: 06.11.2023.
