2. Technical Bid:

- a. Bids both Technical and Financial should be submitted online only.
- b. Bidder should upload the scanned copy of tender fee (Rs 2000.00) or an equivalent amount in US Dollars), which should reach in original to Directorate of Fisheries, Fish Farm Nowabad, Canal Road, Jammu-180016 on or before last date of submission of bids.

- c. Bidder should upload the scanned copy of Earnest Money Deposit (Rs 2,20,000/-or an equivalent amount in US Dollars), which should reach in original on or before to Directorate of Fisheries, Fish Farm Nowabad, Canal Road, Jammu-180016 last date of submission of bids.
- d. Technical Details of Germplasm (Genetically Improved Eyed Ova) conforming to stipulations in bid.
 - e. The average annual financial Turnover of the bidder during last three financial years i.e., 2019-20, 2020-21& 2021-22 should be Rs 1 Crore 10 Lakhsor an equivalent amount in US Dollars. A certificate to the effect should be given by the chartered accountant/equivalent in relevant country.
 - f. Signed bid form (form 1).

 - A certificate by the competent Authority, to the effect that the bidder is registered with Fisheries Breeding/Rearing association in the particular country should be uploaded in the technical bid.
 - p. Experience certificate of Export of germplasm from a Competent Authority
 - q.Performa for submitting the information of introduction of Aquatic Animal/Germplasm from the exporting country.

2. How to fill technical details of germplasm conforming to the bid

The successful bidder shall be selected on the following basis. The method of selection is detailed as under:

Evaluation & Comparison of bids for Eyed Ova procurement:

- a) Bidder shall have to provide the details of 25% additional stock {Genetically Improved Stock of Rainbow and Brown Trout}
- b) Evaluation will be done based on the details of the genetically improved eyed ova of Rainbow and Brown trout, as verified by the certificate from the supplier that the stock is the result of the genetic interventions.

Para - 1: Technical specifications (Technical details for Germplasm)

- The product should be supplied in company's original packing having proper batch no/date, date of Breeding/Stripping. The early stages of the eyed ova shall be supplied.
- 2. The ordered quantity shall have to be supplied within 15 days from the date of issuance of supply order by the Department. Supplier is required to remain in constant touch with the Chief Project officer, Trout Fish Farming Project, Kokernag, (Member Secretary) to ascertain the requirement of supply in different batches of germplasm from time to time.
- 3. Permission to import eyed ova of Rainbow and Brown trout will be obtained in writing from the Department of Fisheries, Ministry of Fisheries Animal Husbandry and Dairying Govt. of India by the Department of Fisheries, UT of Jammu & Kashmir, which will be provided to the successful bidder at the time of issuance of supply order.

- 4. The supplier/registered dealer must ensure the supply of only genetically improved strain of eyed ova ofboth Brown and Rainbow Trout obtained through selective breeding for better performance in terms of growth and survival.
- 5. The Germplasm is mandatorily to be supplied only at eyed ova stage (early phase).
- The supplier has to submit history/pedigree and growth performance of the imported strain on the letter
 head of the company.
 - The eyed ova should be fertile to maintain the pure line of brood stock.
 - 8. The supplier has to submit a certificate duly issued from the government of export country to the effect that the farm site is free from VHS/IHN/IPN and should be committed to high sanitary procedures, ensuring the consignment is free from OIE-Listed diseases, infections and infestations in force in 2023
 - Infection with Aphanomyces invadans (epizootic ulcerative syndrome)
 - · Infection with epizootic haematopoietic necrosis virus
 - Infection with Gyrodactylussalaris
 - · Infection with HPR-deleted or HPRO infectious salmon anaemia virus
 - · Infection with infectious haematopoietic necrosis
 - · Infection with salmonid alpha virus
 - · Infection with viral haemorrhagic septicaemia virus
 - · Infection with Aeromonas salmonisida
 - The supplier should ensure that the transportation is done maintaining a cold chain in a specifically designed container. The said container should not be exposed to any kind of X-ray/radiation at the airport.
 - 10. The stock is mandatorily to be recertified for pathogenic species-specific quarantine by a designated committee of the Department of Fisheries Govt. of Jammu and Kashmir and scientists from ICAR- DCFR.
 - 11. Both male and female eyed ova fertile stocks should be supplied. However, in case of non-availability of both sexes monosex ova preferably female shall be supplied.
 - The importer shall ensure all bio security measures and quarantine of the imported stock.
 - Any subsequent import will be allowed subject to the submission of report on the performance of previously imported stock.

Para - 2: Technical specifications (Technical details for Germplasm)

- In case the consignment does not pass quarantine, the entire consignment shall be destroyed at the suppliers cost as per the prescribed protocols.
- 2. If during the course of inspection, it comes to the notice of competent authority that the supplier willfully suppressed important information or, deliberately furnished wrong information, the consignment being imported is not the same or, the imported stock of species for which approval was not obtained, in such cases, the supply order shall be cancelled instantly and the imported stock destroyed without any notice to the supplier.

- 3. Cold Chain should be maintained during the transit (Temperature <4°C), for which the expenses are to be borne by the exporting agency. Any expenses incurred due to any exigency during transit to IGI, Airport, New Delhi, shall be borne by the Exporting Agency.
- 4. Fine or punishment may be imposed by Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying Govt. of India, for the violation of the guidelines.
- 5. Director Fisheries reserves the right to accept or reject any tender without assigning any reason thereof. In case of any dispute/doubt the decision of the Director Fisheries shall be final. All disputes shall be within the jurisdiction of J&K UT Courts.

Para - 3: Technical specifications (Technical details for Brown Trout Feed)

- The feed should be of extruded variant with high elevated digestible energy level and high protein and lipid levels.
- The feed should be supplied in the form of Starter diet, Crumbs and extruded pellet feed of size 1mm, 2mm and 3mm.
- The protein content for the Starter feed and Crumbs should be 55-60%. The protein content for extruded pellet 1mm and 2 mm should be 45-50% and for pellets of 3 mm the protein should be 40-45%.
- The moisture content of the feed should be less than 10%.
- In each batch the proportion of Starter and crumbs should be 30% of the total quantity of the feed supplied. Among the Starter and Crumbs, the starter diets shall constitute at least 35%.
- The bidder should furnish the certificate for the competent authority that the feed supplied is manufactured by an authorized and registered manufacturer.
- 7. The shelf life of the feed consignment should not be less than nine months.
- Any defect damage or spoilage of feed found during transit shall not be accepted and destroyed at the expense of the bidder.
- 9. The rate for the feed should be quoted per kg.
- 10. The bidder/supplier should provide the certificate reflecting proximate composition of fish feed with emphasis on protein content from an authorized laboratory from the exporting country.
- 11. The Taxes, levies, octroi, Custom duty and other taxes shall have to be borne by the bidder.
- 12. The payment shall be made only after test report of the samples from the authorized testing laboratory in India.

INSTRUCTIONS TO BIDDERS (ITB)/Eligibility

1. The invitation for bids is open to all eligible bidders who shall supply the Eyed Ova and Feedfrom Denmark. However, Bids from principalbidders or through their authorized representatives in India shall also be accepted. Bids of bidders quoting asauthorized representative of principal bidder would also be considered to be qualified technically provided their principal bidder meets out all the criteria as laid in NIT, for which the bidder should upload legally enforceable tender specific authorization.

- 2. The average annual financial Turnover of the bidder during last three financial years i.e.2019-20, 2020-21& 2021-22 should be Rs 1 Crore 10 Lakhs or an equivalent amount in US Dollars. A certificate to the effect should be given by the chartered accountant/equivalent in relevant country.
- 3. The bidder should be registered with recognized Fish Breeding/rearing Association of the country. A certificate to the effect should be uploaded in the technical bid.
- 4. Bidders shall not be under a declaration of in-eligibility for corrupt and fraudulent practices.
 - Joint ventures and Holding Companies-Credentials of the partner of joint ventures cannot be Clubbed for compliance in the NIT, each partner must comply with all the NIT criteria independently.
 - Supporting documents submitted by the bidder must be certified/authenticated by person authorized to sign the tender on behalf of bidder.
 - All financial standing documents shall be certified by chartered accountant or equivalent in relevant country. Indian agents of foreign bidders should furnish their PAN.
 - Germplasm (eyed Ova) to be supplied under the contract shall have their origin in eligible source country only.
 - 9. The bidder shall bear all costs associated with the preparation and submission of its bid.
 - 10. Failure to furnish required information shall be at bidder's risk and may result in rejection of his bid at the time of his evaluation.
 - 11. Any prospective bidder requiring any clarification of the bidding document may request for clarification through e-mail on <u>jkfdkmr@gmail.com</u> or dir-fisheries@jk.gov.inon any working day before the deadline for submission of bid.
 - 12. The purchaser at its discretion may extend the deadline for submission of bids.

13. Bidder shall have to submit, a EMD in the amount as mentioned below:

- 14. The bid security is required to protect the purchaser against the risk of bidder's conduct.
- 15. The bid security should be submitted in favor of Chief Project Officer, VTTF, Kokernag, J&K, India, in the shape of CDR/FDR. Must be submitted in original before the last date of submission of bids. Shall be valid for a period of one year. The Earnest Money of unsuccessful bidders shall be released immediately. Of successful bidders, bid security will be released upon the bidder signing the contract and furnishing Performance Security.

Award of Contract

- 16. The contract shall be awarded to the bidder whose bid has been determined to be substantially responsive.
- 17. Upon successful award of contract to the bidder, the constituted committee shall decide the quantum of the eyed ova required from time to time (in batches), depending upon the availability of space.
- 18. The award of contract shall be subject to the satisfactory report of the above selection team before supply of the germplasm.

- 19. The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract. Purchaser shall not be liable to pay liability to the affected Bidder or bidders.
- 20. The notification of award will construe the formation of the contract & furnishing of performance security by the bidder. The Purchaser will immediately discharge its bid security on submission of performance security.
 - Successful bidders shall sign the Contract (with date) on Stamp Paper or equivalent legal document in bidders country and return it to the purchaser.

Performance security

22. Within 15 days after the supplier's receipt for Notification of Award, the Supplier shall furnish Performance Security to the Purchaser for an amount as detailed below that shall be valid for one year or up to completion of performance obligation whichever is later.

- 23. The Proceeds of the performance security shall remain as a security for any loss resulting from Supplier's failure to complete its obligations under the contract.
- 24. The Performance security will be discharged by the Purchaser and returned to the supplier on written notice of the Supplier 30 days following the date of completion of the Supplier's performance obligations i.e., successful completion of quarantine at New Delhi and satisfactory visual observation as per the protocol prescribed by Department of Fisheries, Govt. of India in respect of all the batches of eyed ova.
- 25. The Performance security shall be in denomination of INR and shall be in one of the following forms:
 - FDR/CDR issued by a nationalized scheduled bank located in India pledged to Member Secretary, UT/National Level Procurement, Quarantine and Monitoring Committee, as the case maybe.

Insurance

- 26. The Goods supplied under the contract shall be fully insured against loss or damage incidental to transportation, storage and delivery till New Delhi.
- 27. The insurance shall be in an amount equal to 110 percent of the CPT value of the Goods from "Warehouse to warehouse (final destination)" on "All Risks" making purchaser the beneficiary.
- 28. The Supplier warrants that the germplasm (Male & Female stock of eyed ova of genetically improvedRainbow and Brown trout) supplied under this Contract are free from OIE-Listed diseases, infections and infestations in force in 2023
 - Infection with Aphanomyces invadans (Epizootic Ulcerative Syndrome)
 - Infection with Epizootic Haematopoietic Necrosis Virus
 - · Infection with Gyrodactylussalaris
 - · Infection with HPR-deleted or HPRO infectious salmon anaemia virus
 - Infection with Infectious Haematopoietic Necrosis
 - · Infection with Salmonid alphaVirus
 - Infection with Viral Haemorrhagic Septicaemia Virus
 - · Infection with Aeromonas salmonicida

Delivery

29. The terms for delivery/ import (for allocation of responsibilities) shall be governed by incoterm CPT(Carriage Paid To) as described by international chamber of commerce and as mentioned in annexure 16 of Manual for procurement of Goods.

- 30. The delivery schedule shall be as follows, Delivery of consignments shall be in phased manner as communicated by Member Secretary, in New Delhi within 20 days of placement of Supply order.
- 31. The actual quantity of eyed ova and feed may vary as per requirement of the purchaser.

Payment

- 31. The method and condition of payment to be made to the supplier under this contract shall be 30% of the payment on boarding of consignments against which a bank guarantee of an equal amount should be submitted to the Department.
- 32. 40% payment on arrival of germplasm (eyed ova) at New Delhi and Clearance by the National/UT level Procurement Quarantine and Monitoring Committee.
- 33. 30% of payment after satisfactory completion of quarantine at New Delhi/Post-Dispatch quarantine and receipt of satisfactory reports as per health protocol prescribed by Department of Fisheries, GOI, clearly mentioned in the NIT under Terms and Conditions Column.
- 34. 85% Payments shall be made through letter of Credit subject to UCP 600 and 15% through direct payment after satisfactory completion of quarantine in India and receipt of satisfactory test report as per health protocol prescribed by Department of Fisheries, GOI.
- 35. Document which the supplier needs to furnish while claiming payment shall be specified in the Letter of Credit, which shall include as follows,
 - A. Commercial invoice in triplicate as per the supply order duly signed and stamped by the Supplier.
 - B.Packing list in triplicate.
 - C.A certificate of country origin from a recognized chamber of commerce or any other designated agency by the local Govt for this purpose in original and copy.
 - D.Full set of signed stamped airway bill, evidencing shipment from the country to India.
 - E.Insurance policy in favor of the purchaser for 110 CPT covering all risks.
 - F.Satisfactory health/condition certificate issued by the competent Authority of Fisheries Department of the country.
 - G.Certificate from the practicing veterinarian/Fisheries expert of the country that the germplasm is as per the specifications desired in the NIT.
 - H.A certificate from the beneficiary that he shall be entirely responsible and pay all taxes, duties, octroi, Quarantine charges at IGI airport New Delhi and other requirements until delivery of the eyed ova consignment till New Delhi.
 - J.Certificate of export of eyed ova of rainbow and brown trout from the country to India to be signed by concerned country fish farm Authorities.
 - K.A certificate from the beneficiary that in case the germplasm is found positive for any disease as per OIE guidelines, the consignment will be destroyed at the supplier's expense.
