Note 1: Tender document shall be issued only to registered original manufacture having past experience and successful installation certificates from the concerned agencies having valid registration certificate, attested copy of GST number & Tax clearance certificate from the competent authority.

Note 2: The tenderers are required to go through the terms and conditions minutely and clear any doubt before submitting their tenders. The tenderer shall sign each page of this document in token of acceptance of the terms and conditions mentioned herein and submit the same along with the rate offer.

The tender should be uploaded on the official website (www.jktenders.gov.in) and the following documents are required to be submitted for Technical bid in a sealed envelope on which Tender Notice.No. and date should be inscribed.

- 1. Call Deposit Receipt for an amount of Rs.300000/- Rupees Three lac only.
- 2. Registration certificate from Competent Authority for being registered manufacturer.
- 3. Attested copy of GST Number.
- 4. Tender Document duly signed.
- 5. Income Tax clearance of Last two years.
- 6. DD for an amount of Rs.3000/- on account of Tender Document fee.
- 7. Past experience certificate for successful installation of cages from the concerned agencies.

Absence of any above documents shall be declared unqualified for tender process.

# General instructions/Terms & conditions:

- 1. The tender document shall be downloaded from 29-01-2020 against payment of Rs.3000/-(Non-Refundable) pledged to Accounts officer Fisheries Department in shape of Demand Draft and shall be uploaded from official website www.jktenders.gov.in upto 19-02-2020 The hard copies shall be delivered personally or sent by registered post at Directorate of Fisheries Canal Road Nowabad Jammu-180016 by or before 20-02-2020 upto 4PM. However no hard copy of finance bid is required. The tender shall be opened on 24-02-2020 or any other date which shall be notified on departmental notice board convenient to opening authority in presence of tenderers who may like to be present. However, if the tender opening day happens to be a holiday or office remains closed due to any other reason, then tenders shall be opened on next working day. Direct or indirect canvassing on the part of tenderers or their representatives shall render his/their tender as disqualified.
- 2. The tender shall be accompanied by CDR/FDR for the amount of Rs. 300000/- of a scheduled bank and pledged to Accounts officer Fisheries Member Secretary State Level Purchase Committee. The registered SSI units shall furnish the CDR for such amount as is applicable in their favour as per standing Govt. Instructions. They shall have to make available copies of relevant Govt. orders entitling them to furnish CDR/FDR for lesser amount or any other concession/preference etc. Such units shall furnish proof of being registered SSI Units (Attested Photostat copy of Registration certificate) manufacturing the items and their units being functional.
- 3. The successful tenderer shall in no case sublet his contract for supplies to any person or agency.
- 4. The rates offered shall be inclusive of all taxes, duties, GST, carriage or any other incidental charges etc. and the supply and installation of the Cage Structure shall be done by the supplier according to the time schedule fixed by the competent authority.
- 5. The department can if need arises, verify various documents such as Registration Certificate, Income Tax Clearance Certificates etc, furnished by the supplier from concerned departments



- 6. The approved/accepted rates shall be valid for one year from the date of issuance of rate contract.
- 7. CDR/FDR of successful tenders shall be released only after successful completion of the contract. The CDR/FDR of II and III lowest tenderer shall be released after two (2) months from the date of issuance of supply order/allotment in favour of successful tenderer.
- 8. The successful tenderer shall have to execute an agreement (on non-judicial paper of Rs.5/with attestation of Notary) with the department for due fulfilment of the terms of NIT/supply order. However in case of failure to execute such agreement, the terms and conditions of NIT/Rate contract shall be still binding upon him.
- 9. The supply order shall depend on availability of funds and requirement of the Department from time to time.
- 10. The supplies shall be of standard quality and free from defects strictly as per specifications mentioned in supply order. In case materials are found below standard or defective, same shall be rejected at the risk and cost of supplier. For this purpose the Department shall frame inspection/verification committee which will ascertain the quality of materials and also verify quantity supplied by the supplier before taking such materials on books.
- 11. The ordered quantity shall have to be supplied and installed within 25 days from the date of issuance of supply order by the Department. Supplier is required to remain in touch with the Department to ascertain the requirement of various items from time to time. Copy of the supply order shall be sent to the address of the supplier. In case supplier makes any delay in supplying the required materials the same shall be arranged from any other alternate sources at his risk and cost.
- 12. Payment of the supplies shall be made after the supply is dully verified and accepted as per the conditions mentioned above. The supplier is also required to furnish the Xerox copy of his PAN CARD as well. Deduction @ 2% TDS on account of GST supposed to be deducted where ever applicable at-source, implemented vide SRO 433 dated 29-09-2018 w.e.f 01-10-2018 shall be deducted from each supply, as rate contract exceeds 2.5 lacs.
- 13. Director Fisheries reserve the right to accept or reject any tender without assigning any reason thereof. In case of any dispute/doubt the decision of the Director Fisheries shall be final. All disputes shall be within the jurisdiction of J&K Courts.
- 14. Preference shall be given to the experienced bidder, necessary experience/performance certificates /documents must be enclosed.
- 15. Payments shall be subject, satisfactory verification report as per specifications, by a committee of experts to be constituted by Director Fisheries.
- 16. Multinational companies having experience in supply and installation experience can also participate in the bid process.
